відповідно до європейських стандартів, не втративши при цьому своїх переваг та самобутності, автентичного шляху розвитку.

Забезпечення сучасного рівня змісту освіти ϵ головною складовою якості освіти, яка повинна відповідати державним та міжнародним стандартам. Вирішення цієї проблеми пов'язане із системою контролю якості освіти у вузі, їх відповідність сучасному стану розвитку суспільства, науки.

INTERNATIONAL PROGRAMS FOR UKRAINIAN STUDENTS AND ACADEMIC STAFF

International cooperation has recently become an immensely important part in the system of higher education in Ukraine. Both students and academic staff are motivated to take part in international programs. Students can participate in projects to study for a term at a university abroad. Academic staff actively apply for grants and international fellowships. The latter are required to get a title of both associate professor and professor.

A great many organizations and agencies offer volunteer opportunities abroad. NGO Unit publishes offers of educational programs and volunteer work in Italy, Turkey, Sweden, Poland, Slovakia and others. UniStudy offers international education programs, scholarships, training courses and grants.

Salto is another resource worth mentioning. They have an impressive variety of training programs, both short- and long-term. All the offers are easy to sort by country, organizer, participation form, etc. It should be noted that various activity types are available: study visits, partnership-building activities, seminars, training courses, conferences, and e-learning.

However, limitations should be born in mind. Most often they are about activities and professional interests of participants and a country of origin. Naturally, a financial aspect of international programs is of interest to both students and academic staff. It's important to stress that conditions differ. Depending on the preferences, it's possible to find even those with free accommodations. Despite the fact that normally travel expenses are reimbursed, participants should have funds to buy tickets. All in all, no matter what program is of interest, it's necessary to double check all the details before applying for participation.

Erasmus+is known as a global organization providing international programs. They can be short-term mobility programs (for a period of 3-12 months) for Ukrainian bachelors, masters, graduate students, doctoral students as well fellowships / teaching and training courses (for a period of 5 days to 2 months) for teachers, academic staff and administrative staff of higher education institutions.

Volunteer projects should be highlighted separately. The duration of projects vary greatly, but normally it is 3-6 months. The location can be either a city or in the country. However, the latter is more common. The projects are mainly integrational, environmental or educational, aimed at sustainability, tolerance and skill development.

At the moment, most of organizations still offer international programs for Ukrainians. Meanwhile, several non-profit groups have been founded. One of them is #ScienceForUkraine, which has a mission of gathering and sharing information to support universities on national and international levels, developed for graduate students and researchers directly related to the academic institutions in Ukraine.

All over the world, there are initiatives for Ukrainian students and academic staff who were forced to leave Ukraine because of the war. There are numerous calls for visiting students and university teachers.

At the same time, remote fellowships and scholarships are offered for Ukrainian researchers. In Germany, they are provided by German Funding for Researchers, Philipp Schwarz Initiative, Volkswagen Stifung, Gerda Henkel Foundation, as well as universities and institutes, including University of Tubingen, LMU Munich, Bremen University, Leibniz University and others. In other countries, it's mostly universities that offer emergency funding for Ukrainian researchers: Austria – University of Graz, the Czech Republic – Charles University, Estonia – University of Tartu, etc. However, it should be born in mind that the programs and universities are accepting applications in certain spheres. To be exact, Amsterdam University has visiting research fellowships in law or policies related to health, The Max Planck Institute for Innovation and Competition is committed to support scholars with a background or interest in Competition Law, Intellectual Property Law, Innovation Economics or Entrepreneurship Research, etc.

It should be pointed out additionally that many universities now offer reduced tuition fees. However, applicants should remember that English knowledge is required. Plus, a motivation letter and good school grades are necessary.

Thus, international cooperation, available fellowships and strong support of Ukrainian students and academicians by developed countries offer various options of professional development.
